## **DECISION AWARDING DAMAGES**<sup>1</sup>

**Dorsey**, Chief Special Master:

On July 18, 2017, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the “Vaccine Act”). Petitioner alleges that she suffered injuries to include a shoulder injury related to vaccine administration (“SIRVA”) after receiving the influenza vaccine in her left deltoid on October 11, 2016. Petition at 1, ¶¶ 1, 5. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On January 23, 2018, a ruling on entitlement was issued, finding petitioner entitled to compensation for her SIRVA. On March 5, 2018, respondent filed a proffer on award of compensation (“Proffer”) indicating petitioner should be awarded \$80,000.00. Proffer at 2. In the Proffer, respondent represented that petitioner agrees

with the proffered award. *Id.* Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **the undersigned awards petitioner a lump sum payment of \$80,000.00 in the form of a check payable to petitioner, [REDACTED].** This amount represents compensation for all damages that would be available under § 15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.<sup>3</sup>

**PROFFER ON AWARD OF COMPENSATION<sup>1</sup>**

**I. Procedural History**

On July 18, 2017, [REDACTED] (“petitioner”) filed a petition for compensation (“Petition”) under the National Childhood Vaccine Injury Act of 1986, 42 U.S.C. §§ 300aa-1 to -34, *as amended*. She alleges that, as a result of receiving the influenza (“flu”) vaccine on October 11, 2016, she suffered from a left shoulder injury related to vaccine administration (“SIRVA”). Petition at 1-2. On January 23, 2018, respondent filed his Vaccine Rule 4(c) report, conceding causation-in-fact for a SIRVA to petitioner’s left arm. On January 23, 2018, the Chief Special Master issued a ruling on entitlement, finding that petitioner was entitled to compensation for a SIRVA to petitioner’s left arm.

**II. Items of Compensation**

Petitioner has alleged entitlement to the following elements of compensation: past and future pain and suffering; past unreimbursed expenses; and, projected unreimbursable expenses.

Based upon the evidence of record, respondent proffers that petitioner should be awarded \$80,000.00, which represents all elements of compensation to which petitioner would be entitled under 42 U.S.C. § 300aa-15(a). Petitioner agrees.

**III. Form of the Award**

Respondent recommends that the compensation provided to petitioner should be made through a lump sum payment of \$80,000.00, in the form of a check payable to petitioner.<sup>2</sup> Petitioner agrees.
