DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On August 10, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleges that she suffered a shoulder injury related to vaccine administration (“SIRVA”) related to an influenza (“flu”) vaccination she received on September 29, 2015. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On February 2, 2017, a ruling on entitlement was issued, finding petitioner entitled to compensation for a SIRVA. On April 7, 2017, respondent filed a proffer on award of compensation (“Proffer”) indicating petitioner should be awarded \$140,305.01. Proffer at 1. In the Proffer, respondent represented that petitioner agrees with the

proffered award. Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **the undersigned awards petitioner a lump sum payment of \$140,305.01 in the form of a check payable to petitioner, [REDACTED]**. This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.³
